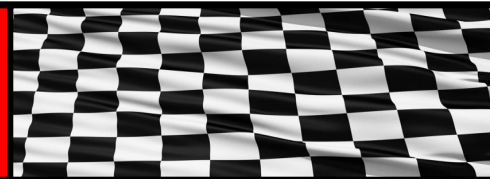

Race Report & Results



The 70th running of the Seattle Outboard Association Lawrence Lake Record Regatta was held over the September 12-14, 2025 weekend and featured a surveyed APBA standard 3/4 mile record course.

40 drivers participated in a Friday insured testing session from 12-6pm. Saturday entries totaled 125 with Sunday coming in at 117. The race had 61 different drivers running in many full fields in the Junior, Stock, Mod and PRO categories.

84 volunteer spots were filled over the 3 day event with 48 heats being completed on Saturday and 14 heats on a wind shortened Sunday. A total of 9 records were set over two days of racing. Congratulations to the record setters and the race committee on an excellent job.
